Terms of Participation

Exhibition and Participation Conditions for the Conference and Exhibition - InWaterTec 2009

1. Registration Procedure

The official registration form must be completed to order a booth or be registered for the conference. The signed registration confirms that the exhibitor/participant accepts the "Terms of Participation". Regulations concerning industrial and trading law must be followed, particularly those for environmental protection, fire prevention, accident prevention, company trademarks and price labelling.

2. Admission

The event organiser can exclude individual exhibitors or suppliers from participation, if there are legally justified grounds, particularly if there is not sufficient space available. Exclusion of competition can neither be a requirement nor prohibited. The conclusion of the contract between the event organiser and the exhibitor is effective once the exhibitor has received confirmation of admission or an invoice. The exhibition organiser is entitled to request an immediate termination of contract, if there is a delay in payment despite reminders. In this instance, a charge of 25% of the stand rental price is to be paid to cover costs, which have already been incurred.

3. Withdrawal

If an exhibitor withdraws after the formal booking of exhibition space, 25% of the rental fee must be paid as compensation. If withdrawal will be indicated later than 2 month before the exhibition, 50% of the rental fee and later than 1 month before the exhibition 100% of the rental fee must be paid.

If a participant of the conference withdraws after the formal registration, 25% of the conference fee must be paid as compensation. If withdrawal will be indicated later than 2 weeks before the exhibition, 50% of the conference fee and later than 1 week before the exhibition 100% of the conference fee must be paid.

Withdrawal must be state as notice in writing. It is then only legally effective once the organiser has given its written consent.

4. Terms of Payment

The fee for the trade fair has to be paid 2 weeks after the date of the invoice in order to assure the claim of the booked exhibition space. Exhibitors, who have not paid their rental fee before the beginning of the event, can be excluded from the participation. This does not implement the expiration of the legal bill receivable.

The conference fee has to be paid at latest 2 weeks after the formal registration. In case of paying by check, you have to add a fee of € 10,00.

5. Booth

Booth allocation takes place with regard to the published exhibition plan. In case of multiple orders and special requests, the exhibition organiser allocates booths according to particulars characters such as booth size and technical requirements. A booth can only be moved, if there do exist compelling reasons. It must be promptly stated in a written order.

6. Operation of the Booth

Booths are not allowed to strike before the official end of the exhibition. The exhibition organiser will make arrangements for the cleaning of passages and public facilities. The cleaning of the booths is in the responsibility of the exhibitor, in the course of which waste should be avoided and refuse should be separated when disposed.

7. Liability

The organiser accepts neither responsibility for damage to exhibition objects and booth equipment nor any consequential damage.
